TREASURER'S UPDATE for September 2024 activity:

Budget vs. Actual Report

Being 3 months into the year, we anticipate seeing "routine" revenues and expenses around 25% of projected amounts. Routine can be classified as revenues and expenses that are relatively consistent each month – rentals, state foundation, restricted state aide, salaries, and fringes.

Original projections have been updated to fall in line with the newly estimated amounts that will be reflected on the November 5 year forecast. As stated with each forecast, estimates are based off the best assumptions at that point in time.

Revenues

- Historically speaking, September is a lower revenue month. This can be viewed on the "monthly general fund revenue" graph included in these reports.

Expenses

- Salaries are now reflecting FY25 contracts.
 - Fiscal year to date (July-Sept) show that salaries are \$300,000 lower than where they were at the same time last year.
- Our new bus was delivered and paid for in September.
- Expenses were approximately \$180,000 higher than revenues for the month

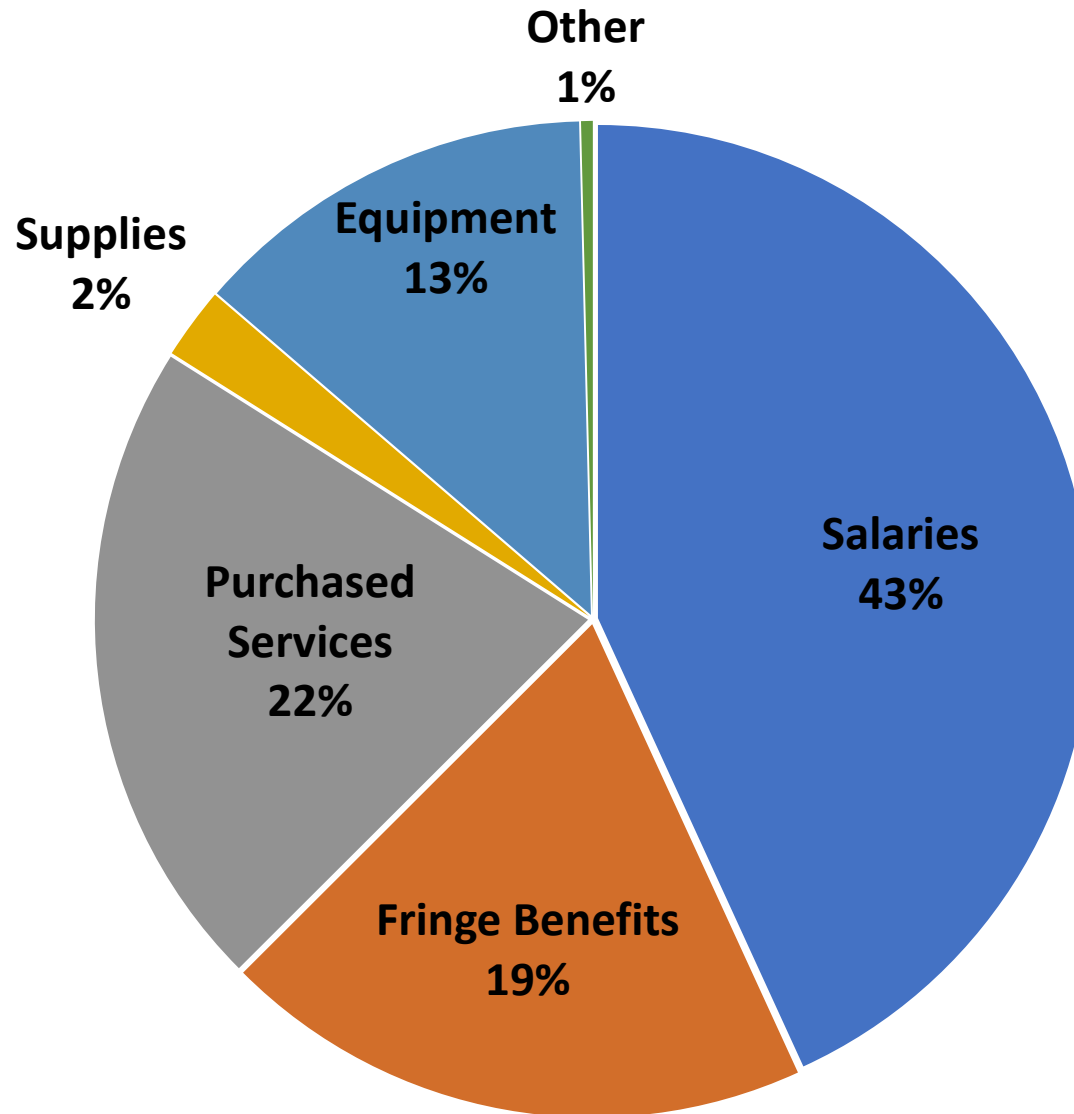

July - Sept 2024 (FY2025)

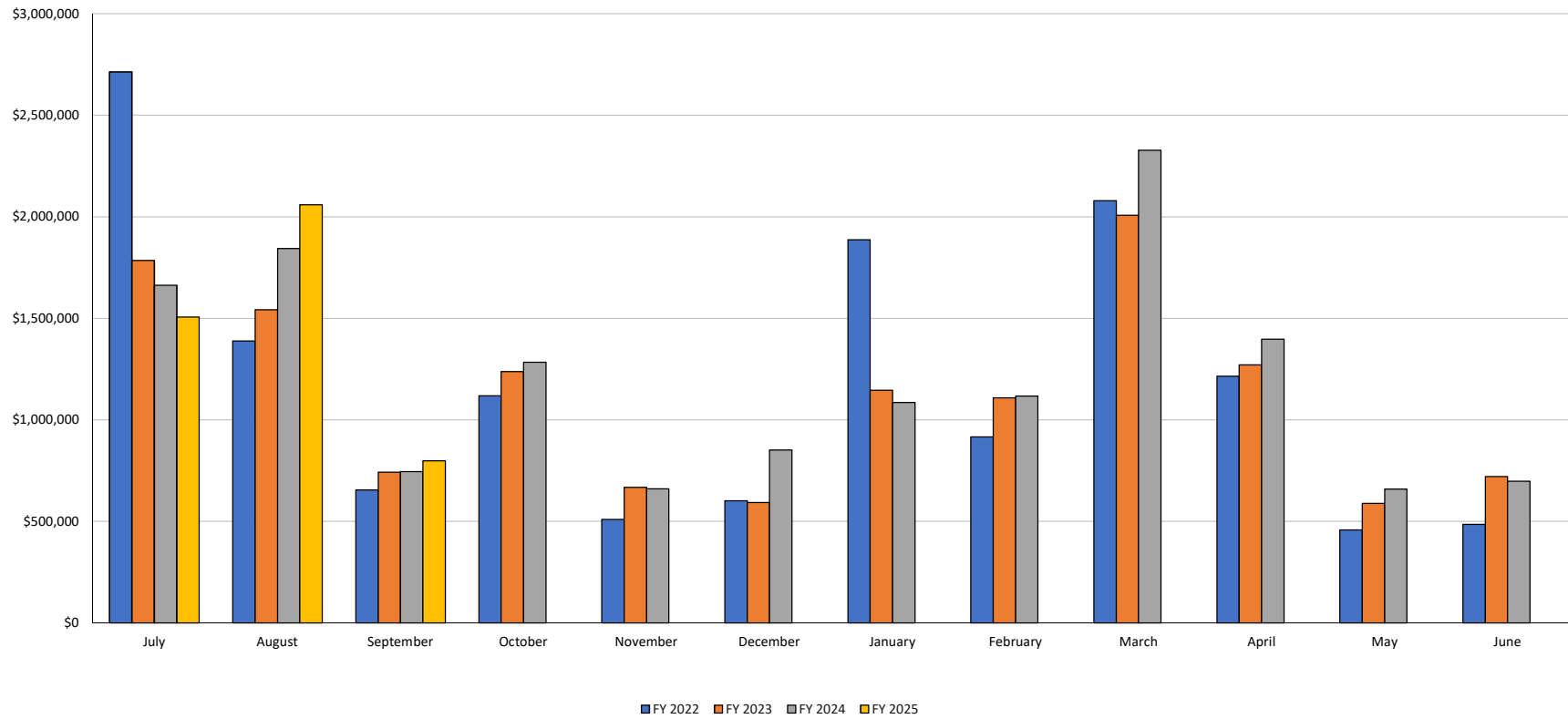

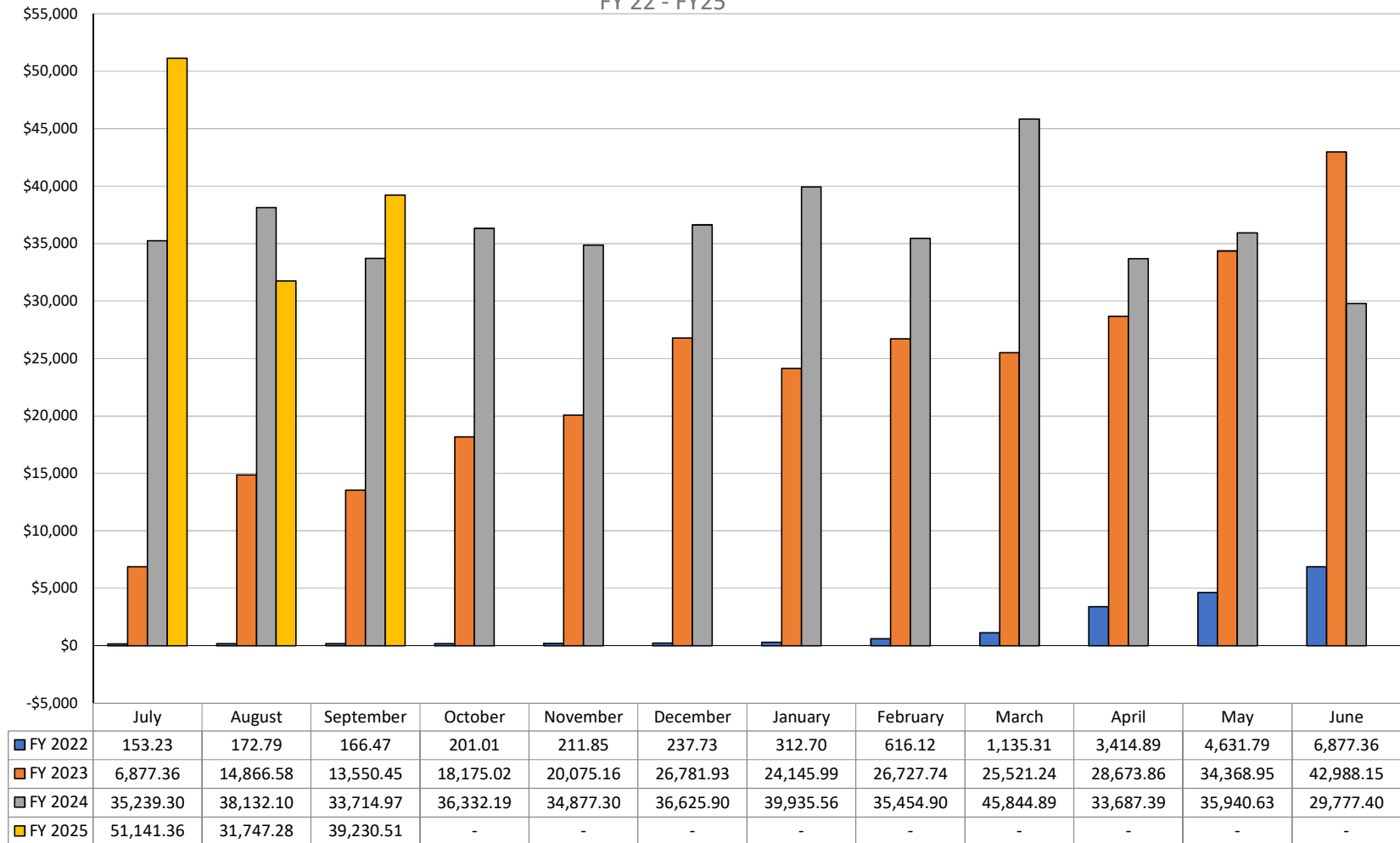
